The colleges/institutions shall forward the shortfall, if any, to the BOPEE Office on **30-04-2019 up to 5.00 p.m.** as already notified vide Notification No. 023-BOPEE of 2019 dated 15-04-2019.

All other terms and conditions of admission shall remain the same as notified vide Notification No. 018-BOPEE of 2019 dated 01-04-2019.

Note:-

- 1) The seats, which have remained unfilled on 21-04-2019 are annexed as **Annexure 'B'** to this Notification, shall be filled up as per the schedule notified by the Board read with the conditions contained in the Notification No. 026-BOPEE of 2019 dated 20-04-2019. The candidates are advised to remain in touch with the BOPEE website **www.jkbopee.gov.in** for updates, if any.
- Since the Board shall be in the process of entering the mopping up round in accordance with the schedule notified by it and in accordance with the MCI schedule, the candidates, who have been granted admission and intend to resign and for the purposes of reiteration may do so within the stipulated period viz 04-05-2019. They should also keep the conditions contained in SRO-48 of 2018 dated 30-01-2018 in mind as already notified from time to time.

4) The unfilled reserved category seats as on 21-04-2019 as per the annexure are hereby treated as Open Merit seats in pursuance to proviso to Section 9(2) of the J&K Reservation Act, 2004, due to non-availability of reserved category candidates despite having been given ample opportunities to participate in the counselling process, and considering that no seat can be filled up after the cut-off date as notified by the MCI. Besides, a special opportunity was also given to reserved categories on 21-04-2019 to participate in the counselling to fill up the seats for the category candidates, and despite all efforts seats still remained unfilled. Any category seat reported unfilled due to resignation by any category candidate shall also be treated as OM seat and filled up along with other seats as per Annexure 'B' to this Notification.
