Consequent upon the mopping up round of the counselling held on 06-05-2019 in pursuance of Notification No. 28-BOPEE of 2019 Dated 30-04-2019 read with Notice No 37-BOPEE of 2019 Dated 04-05-2019, the following MD/MS seats have remained unfilled which shall be filled up on 07-05-2019 in the same manner as already notified:-

1. GMC Jammu

- a. MD/MS Anatomy (3 seats)
b. MD Physiology (1 seat)

2. ASCOMS Jammu

- a. MD Anaesthesiology (1 NRI seat) became available due to upgradation.

Apart from the above, counselling for one seat in **Psychiatry in SKIMS** could not be held on 06-05-2019, which shall also be filled up along with aforementioned unfilled seats on the basis of merit cum preference. The candidates, who had opted for Psychiatry on 06-05-2019 but could not participate due to the non-counselling can also participate and any consequential changes if required would be made during the process of counselling.

Note:

- (1) Only such candidates shall be allowed to participate in the counselling on 07-05-2019 who fulfil all the conditions as laid down in the Notifications/Notices issued regarding the mopping-up round.
(2) The seats becoming available during the mopping-up round due to upgradation if any have also been filled up during the process as hithertofores.
(3) The seats becoming available during the mopping-up round on 07-05-2019 due to upgradation, if any, shall also be filled up during the process.
(4) A consolidated list of the candidates selected during the mopping-up round will be notified on 07-05-2019. The colleges are advised to keep the counters open for facilitation of the candidates as also provided in the MCI Regulations as the last date of taking the admission shall be **12th May, 2019.**
