Consequent upon the mopping up round of the counselling held on 06-05-2019 and 07-05-2019 in pursuance of Notification No. 28-BOPEE of 2019 Dated 30-04-2019 read with Notice No 37-BOPEE of 2019 Dated 04-05-2019 and Notice No. 38-BOPEE of 2019 Dated 06-05-2019, the list of candidates provisionally selected/upgraded for admission to MD/MS and PGD courses 2019 is hereby annexed as **Annexure "A"** to this notification, which shall be available on the BOPEE website jkbopee.gov.in only. It is further notified that:-

- 1. The candidates upgraded/selected shall have to join the college/institution up to 12-5-2019 (4 PM);
- 2. The candidates have to necessarily join the college and no resignation etc. will be considered. Non-joining of the candidates will attract the provisions of SRO-48 of 2018 dated 30-01-2018 as also notified from time to time;
- The colleges are advised to keep the counters open for facilitation of the candidates as also provided in the MCI Regulations as the last date of taking the admission shall be 12<sup>th</sup> May, 2019 and as also notified earlier;
- 4. The colleges shall forward the shortfall, if any, by **12-5-2019 up to 5 PM** enabling the Board to take further action in accordance with MCI schedule for submission of the waiting list;
- 5. The seat as mentioned below have remained unfilled during the mopping up round and candidate, if any, desirous of taking admission against these seats can approach the BOPEE up to 11-5-2019 so that their cases are considered on merits.

(i) GMC Jammu:

- a. MD/MS Anatomy (3 seats)
- b. MD Physiology (1 seat)
- c. Pharmacology (2 seats)

(i) ASCOMS Jammu:

- a. MD Anaesthesiology (1 NRI seat).
- 6. As the Board will be preparing a waiting list against any shortfall as may be reported by the colleges/ institutions, therefore, any candidate who has not been allotted a seat and may be willing to be considered to be included in the waiting list should register himself with the BOPEE office at Jammu/Srinagar up to 13-5-2019 (12 Noon) so that they are also considered. However, mere registration does not confer any right upon such candidates to claim a seat which shall and shall be considered on the basis of shortfall, if any, received and the rules on the subject with due regard to merit of the candidates.

(1) The Board during the counselling process, considered the case of Miss Gurleen Kour Randhawa petitioner in WP(C) No. 1639/2019 and the interim directions of the Hon'ble

High Court dated 3-5-2019 when the candidate was provisionally permitted to register and participate in the counselling. However, it was observed that in accordance with SRO-168 of 2014 dated 10-06-2014 issued in pursuance of J&K BOPEE Act 2002, only permanent residents of the state are eligible for admission. The same position has been notified in terms of BOPEE regulations of 2016 issued in pursuance of Section 23 of the BOPEE Act. There is no provision of seats for non-resident doctors in the rules defining eligibility of candidates as such and the claim of the petitioner having been considered has not been found to be covered under rules, moreover when the eligibility of the candidates has been explicitly defined in Rule-4 of SRO-168 of 2014. Further, SRO-158 of 1995 has under gone numerous changes in view of amendments carried in MCI regulations, the issuance of BOPEE Act 2002, enactment of Reservation Act and rules issued thereunder, the BOPEE rules and the regulations issued thereunder and the eligibility has to be determined only in accordance with the BOPEE rules. The candidate was informed accordingly and a copy of the rules and regulations was also provided to her.

- (2) During the process of counselling, petitioner Syed Ahmad in OWP No. 570/2019 also participated in the counselling on0 06-05-2019. His claim was that he should have been allotted a seat in Surgery in ASCOMS during the counselling on 20-5-2019 which, however was allotted to a higher merit candidate by the BOPEE. During the process of counselling on 06-05-2019, a seat in surgery became available in ASCOMS, which was allotted to the petitioner on the basis of his merit cum preference.
- (3) The Board also considered the interim directions dated 3-5-2019 of the Hon'ble High Court in the case titled Dr. Zulifqar Ahmad vs. State & ors in w.p.(c) 1625/2019 and the candidate was provisionally allowed to participate in the counselling but he did not opt for any available seat on his turn of counselling.
- (4) The Board also considered the interim directions in the Suit titled "Shakir Hussain Shah" V/s BOPEE & Ors before the Hon'ble Court of Ist Additional Munsiff at Srinagar and has filed an application for cancellation of direction dated 4-5-2019 as the liberty was granted for the same. The Board also conducted the counselling in accordance with the rules and in accordance with the MCI schedule notified on the subject, which has also the seal and stamp of the Hon'ble Supreme Court in Ashish Ranjan's case and reiterated on numerous occasions by the Apex Court.

Other terms and conditions shall remain the same as notified from time to time. This issues without prejudice to the outcome of writ petition pending if any on the

subject before any competent court of law.
