The candidates who have appeared for NEET PG/PG Diploma 2018 and NEET MDS 2018 examination and are desirous of participating in the online registration process/counselling/allotment of seats for available seats in the State of Jammu and Kashmir both Government and Private institutions are hereby informed that:-

e-Information Brochure governing such admission shall be available on the website of BOPEE www.jkbopee.gov.in/www.jakbopee.org from 21-02-2018 evening. The seat matrix given in the e-brochure is, however, tentative and subject to changes as may become necessary, which shall be notified in due course of time. The candidates are advised to go through the Information Brochure for admission to medical/dental institutions carefully, ascertaining the eligibility before online submission of registration form;

Further:-

- i) MDS candidates who are eligible to participate in the registration process in accordance with the conditions in the e-brochure can fill in the online registration forms available on the above BOPEE website w.e.f. 23-02-2018 to 01-03-2018. Such candidates shall be required to upload the scanned copies of original documents also;
- Candidates belonging to OM including Sports, JKPM, CDP shall be eligible only if they have obtained minimum score of 233. In respect of other reserved category candidates the cut off score is 204;
- The candidature of any candidate, who has not obtained the minimum qualifying score, shall be summarily rejected as mere filling in of the registration forms shall not confer any right upon him/her for staking a claim on a seat. Mere participation in the registration shall also not confer any right upon the candidates to be allowed to participate in the online counselling process which shall be subject to number of candidates as may be actually allowed to participate in the counselling process depending upon the number of seats available;
- iv) Any candidate who is eligible for registration but is not able to proceed ahead with the online registration form, may contact the BOPEE helpdesk numbers 9419403272/9697383737/9419434133/9469012295/9419150693,

during office hours. For any facilitation other candidates applying for online registration may also contact the above numbers;

- The candidates are, however, advised to be in constant touch with the BOPEE website for instructions/notifications for further admission process. Board shall not be responsible for any delay in publication of any Notification/Notice in the newspapers notwithstanding the fact that the process of uploading of such notices/notifications etc. and publication in the news papers is initiated simultaneously. The delay in publication, if any, is beyond the control of the BOPEE. Any delay in submission of online registration form due to electricity failure or due to any technical failure will not be considered by the BOPEE.
- **Note:-** i) The online registration for MD/MS/PG Diploma courses shall commence from a date as may be notified by the Board separately in due course of time.
 - ii) The MD/MS/PG Diploma candidates are, therefore, advised not to attempt filling in the online registration form as they will not be able to do so till such time the Board activates the registration form in such cases.
