Whereas, the Common Entrance Test (CET) 2019 for admission to B.E./B.Tech. Courses was held on 28<sup>th</sup> April, 2019 at Jammu and Srinagar simultaneously; and

Whereas, in pursuance of Notification No. 22-BOPEE of 2019 dated 12-04-2019, the Answer key was uploaded on Official website of the Board on 28-04-2019 and was kept available till 01-05-2019, thereafter removed; and

Whereas, in pursuance of Notification dated 12-04-2019, the candidates, who appeared in CET 2019 and had any complaint against any answer of a question in the Question Paper, were free to make written representation supported by documentary proof from standard textbooks; and

Whereas, the Board received one representation from the candidate, which was forwarded to the subject expert for their opinion; and

Whereas, in terms of Rule-13 of SRO-168 of 2014 dated 10-06-2014 read with Regulation 7 (VIII, IX, X, XI, XII, XIII, XIV) of J&K BOPEE Regulations-2016, the subject experts after examining the representation, opined two changes in the first Answer Key as under;

- that the answer to Q. No. 73 of series 'B' as represented by the candidate will have Answer "D" instead of "A" and subsequently Q. Nos. 65, 89 and 91 of Question Booklet Series C, D and A respectively will have Answer "D" instead of "A".
- The Question No. 84 of series 'B' as represented by the candidate will have both Answers "A and D" instead of "A" and subsequently Q. No. 94, 110 and 111 of Question Booklet Series A, D and C respectively will have both Answers "A" and "D" instead of "A".

Now, in view of the opinion of the subject experts, the revised Answer key is uploaded and is **available on official website of the Board [jkbopee.gov.in](http://jkbopee.gov.in) only**. The revised Answer Key is final and binding for all concerned. The result shall be prepared accordingly in accordance with the above regulations.

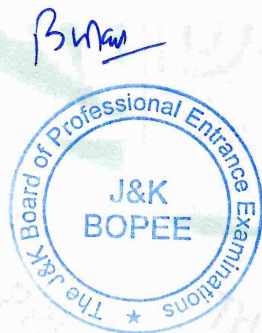
