It is hereby notified for information of all the concerned that as informed by the State Government the Medical Council of India has accorded permission to start MBBS courses in 4 newly established Medical Colleges in the State w.e.f 2019 as under:-

The available seats in the Government Medical Colleges during 2019-2020 including the above will therefore be 800 which shall be filled by the BOPEE in accordance with the standing rules and procedures/ reservation rules applicable to the State Government. As already notified, after the declaration of the NEET UG-2019 result the eligible candidates are required to register themselves online with the BOPEE and upload the documents also.

In addition to the seats in the Government colleges, there are 100 Seats in ASCOMS, Jammu including those under Management quota/NRI which shall also be filled up by the BOPEE. 10 Seats in ASCOMS, Jammu are earmarked for candidates belonging to Poor and Backward Classes whose annual income does not exceed Rs 72000/- from all the sources. The candidates falling in this category should have the requisite certificates prepared well in advance so that such certificates are also uploaded at the time of online registration. The number of seats in Government/Private Dental Colleges has not undergone any change.

The candidates are further advised to go through Notice No. 53-BOPEE of 2019 dated 29-5-2019. The seat matrix shall also be uploaded on the BOPEE website in due course of time along with the Information Brochure. The candidates should therefore remain in touch with the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) for further updates.
