**Subject:- Online Registration of qualified candidates of NEET UG – 2019.**

In Continuation of Notice No. 53-BOPEE of 2019 dated 29-05-2019 and consequent upon the declaration of the NEET UG – 2019 result by National Testing Agency (NTA) on 05-06-2019 and with a view to update the category status and preparing the Provisional State Merit List (PSML) of registered candidates, it is hereby notified that the candidates who have secured the minimum qualifying marks in NEET UG – 2019 shall be required to register themselves and upload the following documents online w.e.f. **17-06-2019 to 24-06-2019**.

1. NEET-UG score card.
2. 10+2 marks card.
3. State Subject Certificate.
4. Category Certificate, wherever required.
5. Date of Birth Certificate (Matriculation).

The cut off score for different categories is as under:-

- a. Open Merit/JKPM (including child of PMF)/CDP/Sports : up to 134
- b. SC/ST/RBA/ALC/OSC (for J&K) : up to 107

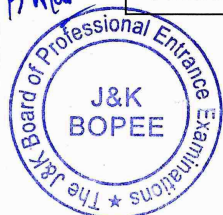
The tentative NEET score list of candidates of J&K, who have appeared in the NEET-UG 2019 shall be notified separately in due course of time after receipt of the result from the NTA which shall be available on the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) only. This list would only be to facilitate the candidates to register themselves and should not be construed as state Merit List, which shall be notified after completion of the registration process. The candidates, in their own interest, are advised to go through Notice No. 53-BOPEE of 2019 dated 29-05-2019 also before proceeding for online registration. Mobile phones should not be used for registration purposes for uploading of documents, as software will not accept the same.

The e-Information Brochure for NEET UG-2019 Courses shall be notified by the BOPEE and will be available on the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) on 12-06-2019. The candidates are advised to go through the e-Brochure before registration/filling up of the preference forms.

Declaration of PSML ( Tentative): 26-06-2019

Online filling up of preference forms: 27-06-2019 to 02-07-2019



**NOTE 1:-**

1. No under process certificate shall be entertained;
2. The category certificates issued only up to the last date of registration shall be entertained. Any certificate issued after the registration date shall not be entertained by the Board;
3. The candidate must fulfill all other criteria as laid down in the NEET-UG 2019 Information Brochure and Information Brochure of BOPEE in respect of NEET-UG, 2019 courses;
4. Any candidate found ineligible at any point of time shall not be allowed to participate in the counseling process notwithstanding the registration/NEET qualifying score;
5. The candidate should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them;
6. Candidates, in their own interest, are advised not to share e-mail password with other candidate/person;
7. Board shall not be responsible for any mistake committed by the candidates, while making registration;
8. After completion of the registration process, Board shall notify the Provisional State Merit List (PSML) of all the candidates, which shall be used for online counseling by the candidates (filling up of the preferences) based on which allotment of seat shall be made;
9. Any candidate, who falls in the merit list but does not register himself/herself or does not upload the documents or the documents uploaded are deficient shall not be considered for allotment of a seat;
10. The candidates, in their own interest, are advised to go through the Information Brochure available on the website of the BOPEE viz. **www.Jkbopee.gov.in** and **go through the technical and other instructions before registering themselves**;
11. Since the admission in the Professional Colleges is time bound, the candidates should not wait for last date of registration as it may even be detrimental to the interest of the candidates(s);
12. The candidates shall have to fill in following field which are mandatory in nature and without which they cannot process further:-
  - i. **Student Roll No.**
  - ii. **NEET Score.**
  - iii. **NEET Rank.**
  - iv. **Date of Birth.**
  - v. **Gender**
13. The candidates, who intend to participate against NRI/HM Quota seats in ASCOMS, Jammu/IDS, Sehora shall also have to register themselves online and submit all such documents and up to the date in the Board office as may be notified by the Board;



14. Candidates are advised to remain in touch with the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and should not wait for publication of Notices/Notification in the papers, which may get delayed for the reason beyond the control of BOPEE.
15. Any candidate, who does not figure in the tentative NEET score list as may be notified by the BOPEE but belongs to the state of J&K (State subject) may approach the Board with all details as notified vide Notice No. 53-BOPEE of 2019 dated 29-05-2019.

**Note 2:-**

1. Such candidates, who have not received 10+2 marks cards from the CBSE/Board, due to the technical reasons, may download the marks card from the website of the concerned Board and upload a self attested copy the same, which shall, however, be at the own risk and responsibility of the candidate. The candidates in their own interest should, however, approach school/ concerned authority and obtain the same, which would be provided before the college/ institution at the time of admission.
2. List of candidates belonging to Sports Category shall be notified separately after receipt of the same from the J&K State Sports Council.
3. The Online counselling for filling up of preferences forms by the eligible candidates for allotment of the seats shall tentatively commence from **27-6-2019 to 02-07-2019**. The candidates are advised to remain in touch with the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) in this regard and for all subsequent developments.

**Note 3:-**

The Online fee for counselling (filling up of preference forms) shall be **Rs. 1500/-** (fifteen hundred only).

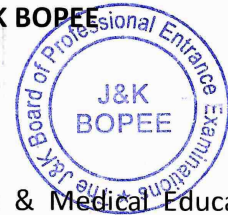
