After notification of the Provisional State Merit List, the online counselling of the candidates for allotment of seats shall commence from 27-06-2019 to 02-07-2019. The candidates shall have to make an online payment of Rs. 1500/- as counselling fee at the time of counselling failing which such candidates shall not be considered for allotment of the seat notwithstanding their merit/rank.
