Subject:- **Allocation of MBBS/BDS seats of Ministry of Home Affairs, Government of India from Central Pool for spouse and children of terrorist victims for the academic year 2019-20.**

(ii) F. No. 17015/48/2019-CT-II dated 22-06-2019 from Ministry of Home Affairs, Government of India, CTCR Division, New Delhi.

Attention of eligible candidates who want to be considered for allocation of MBBS/BDS seats under the Central Pool quota under the Ministry of Home Affairs is invited towards Notice No. 41-BOPEE of 2019 dated 08-05-2019 vide which conditions of eligibility etc. have been notified in detail. Now, the Ministry of Home Affairs vide their communication No. F. No. 17015/48/2019-CT-II dated 22-06-2019 have invited applications for allocation of MBBS/BDS seats from Central Pool for spouse and children of terrorist victims for academic year 2019-20. Briefly the eligibility is reproduced as under:-

(a) **Educational Qualification:**

The candidate must have passed in the subjects of physics, chemistry, Biology/Bio-technology and English individually and have obtained a minimum of 50% marks (40% for SC/ST and 45% for Gen-PH and 40% for SC-PH/ST-PH category candidates) taken together in physics, chemistry, biology/bio-technology at the qualifying examination.

(b) **Selection of candidates:**

The selection of candidates will be made on the basis of rank obtained in the National Eligibility-cum-Entrance Test (NEET) – 2019 being conducted by the National Testing Agency. It shall be necessary for the candidates to have obtained minimum marks at 50th percentile at NEET 2019. In respect of candidates belonging to SC/ST, the minimum marks shall be at 40th percentile and in respect of candidates with locomotary disability of lower limbs, the minimum marks shall be at 45th percentile.

(c) **Reservation:**

22 ½ % of the seats allotted to each Government Department concerned will be reserved for students belonging to SC/ST. The break-up of this reservation will be as follow:-

- A distinct reservations of 15% for scheduled castes and 7 ½ % for scheduled tribes.
- The reservation as mentioned in sub para (a) above, can be inter-changed. Thus, if a sufficient number of candidates are not available to fill up seats reserved for scheduled

tribes, they may be filled up by suitable candidates from scheduled castes and vice-versa and

- (c) If the number of available scheduled castes and scheduled tribes qualified candidates is less than 22 ½% of the seats, the balance can be given to non-scheduled caste and scheduled tribe candidates.

Applications in duplicate are invited from eligible candidates upto **10-07-2019 (2.00 p.m.)** from eligible candidates alongwith all relevant documents as mentioned in Public Notice No. 41-BOPEE of 2019 dated 08-05-2019, which is available on BOPEE website (www.jkbopee.gov.in) on the prescribed format, which also is available on the said website only or can be obtained from the BOPEE office, Srinagar/Jammu during working days for its onward transmission to the Ministry of Home Affairs, Government of India for further appropriate action.

Further, Board does not guarantee or undertake that mere submission of applications shall confer any right to the applicant for his/her selection, which shall be done by the concerned Ministry, Government of India in accordance with the rules/procedures on the subject.


