**Notification No.61-BOPEE of 2019 Dated 08-07-2019**

Consequent upon completion of first round of counselling of NEET UG 2019 on 15-07-2019, the second round of counselling (physical) for filling up of the vacant seats in Government/Private Colleges, if any, shall be conducted w.e.f. 18-07-2019 to 20-07-2019 in the Board Office Jammu/Srinagar as per the schedule as may be notified by the Board:-

The candidates:-

- i) allotted Government/Private Colleges in the first round of online counselling but who have not joined because of one or the other reason shall be given an opportunity to compete against the Government seats on the basis of merit cum preference;
- ii) who were allotted seats in ASCOMS, but did not join, will ordinarily not be considered for re-allotment in the said College unless they produce requisite documents in support of their ability to meet the financial requirements of the College as it has been noticed that many candidates have failed to take admission in view of their inability to pay the fee etc;
- iii) who figure in the PSML but have not participated in the first round of online counselling shall be eligible to participate in the physical round of counselling;
- iv) who did not get a seat during online round of counselling shall also be eligible to participate in the counselling;
- v) desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on their respective date of



- counselling between 8.00 a.m to 10.00 a.m. to be eligible to participate in counselling on their turn/rank;
- vi) participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
  - vii) shall have to submit fresh preferences on their respective date of counselling;
  - viii) are advised to go through the Information Brochure available on BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in). Other conditions mentioned there but not mentioned above shall apply.

**Note:-**

- A) The candidates who could not register themselves online and do not figure in the State Merit List are given an opportunity to register themselves with the BOPEE Office upto 17<sup>th</sup> of July, 2019 (4.00 p.m.) so that they are assigned rank and considered for allotment of seats on the basis of their merit cum preference during the second round of counselling, if they choose to participate they shall have to produce all original documents and signed copy of such documents for verification.
- B) Besides:-
- i) 5 seats in DDH in GDC, Srinagar (OM=3, STGB=1 and RBA=1);
  - ii) 25 seats under HMQ in ASCOMS;
  - iii) 10 seats under NRI in ASCOMS;
  - iv) 10 seats under NRI in IDS;
- are also available and shall be filled up during second round of counselling as also notified earlier.
- C) The candidates should weigh their options of allotment of seat carefully before formally approaching the Board for participation in the second round of counselling with a view to avoid un-necessary rush of candidates during the process of counselling. Since the rank has been notified earlier and the availability of seats is now notified in advance, therefore, the candidates can better visualize the prospect of allotment of seat.
