Consequent upon receipt of shortfall from Government College of Education, Jammu vide their letter No. GCOE/J/2019/808-810 dated 20-07-2019 after the last date of joining of candidates pursuant to Notification No 60-BOPEE of 2019 dated 07-07-2019 read with Notice No 69-BOPEE of 2019 dated 15-07-2019, the candidates figuring in **Annexure "A"** to this notification, have been provisionally selected for admission to B.Ed. Course-2019 in **Government College of Education, Jammu** against the said shortfall. The Principal of the College will get the following certificates in original verified from the Incharge admission and countersigned by him/her before allowing the candidates to complete their admission formalities:-

- (i) Qualifying Marks Certificate (10+2+3);
- (ii) Permanent Resident Certificate;
- (iii) Category Certificate, if any; and
- (iv) Character Certificate.
- (v) Date of Birth (DOB) Certificate.

This is subject to having passed B.A/B.Sc./B.Com/BCA/BBA or its equivalent examination from a recognized University/Institution according to 10+2+3 pattern with not less than 50% of marks in aggregate in the qualifying examination in case of Open Merit candidates and 40% of marks in aggregate in case of Reserved Category Candidates.

The candidates shall report the **Government College of Education, Jammu** upto **31<sup>st</sup> of July, 2019 (4:00 P.M.)** along with their relevant Certificates in **Original** and the **Electronic Admit Card** downloaded by them from the official website(s) of BOPEE.

The Head of the Institution shall send within the prescribed last date the Roll Nos., Rank and Names of the candidates, who fail to complete their admission formalities or who may be otherwise ineligible for having failed to pass the qualifying examination with the requisite percentage as **SHORT FALL** on **31<sup>st</sup> of July, 2019** upto 5.00 P.M. to the BOPEE office, Srinagar/Jammu positively.

**NOTE:**

1. The Application Forms for admission to B. Ed. courses were invited from the aspiring candidates including those, whose result of qualifying examination was awaited. Thus, mere enlisting of any candidate in the annexed list will not confer any right upon him/her to claim admission, if otherwise found ineligible.
2. The details of candidates found ineligible, if any, shall be submitted by the college to the Board along with the shortfall.
3. Rank 24 whose result was withheld for want of deficient documents, has been released and included in the same Select List. Similarly, result of rank 651 whose result was withheld earlier, is also released after having completed the deficient documents.
4. The Board has received representation from some candidates bearing ranks 172 and 645 that they could not join the college on the basis of selection during first round of allotment. Having considered these representations, they have been included in the current list, on the basis of their merit.
5. As a consequence of have been allotted to Open Merit (OM) candidates.
6. The candidates, who have failed to deposit their deficient Documents/Certificates till date, if any, have not been considered for admission in the selection process.
7. The candidates with rank 108, 124 (SC), 111, 119 (CDP), 113 (OSC), 123 (STGB) who were selected in their respective categories vide Notification No. 060 of BOPEE Dated 07-07-2019 are now/hereby treated to have been selected in Open Merit.
