Vide Notice No. 74-BOPEE of 2019 dated 25-7-2019, the details of the unfilled seats at the end of 2<sup>nd</sup> round of counselling held on 18-7-2019 and 19-7-2019 with last date of joining as 25-7-2019 has been notified vide Notice No. 74-BOPEE of 2019 dated 25-7-2019. The Board shall fill up these seats as per the following schedule.

The following shall be eligible to participate in the counselling:-

1. In view of limited number of seats the candidates with the score up to 430 (OM M/F ) (MBBS/BDS) and 350 for reserved categories ( STK/CDP/RBA Females Dental) and who have registered themselves shall only be eligible to participate against Seats in Government/ ASCOMS.
2. The candidates, who have been allotted seats in ASCOMS during the first and 2<sup>nd</sup> round of counselling but have not joined the college shall not be eligible to participate in the counselling.
3. The candidates who have been allotted seats in IDS during the first and 2<sup>nd</sup> round of counselling but have not joined the college shall not be eligible to participate in the counselling at least on 3<sup>rd</sup> August 2019. However the Board may consider such candidates for future counselling, if any, subject to any further shortfall received from the college. All

other eligible candidates can participate in the counselling for the vacant seats in the IDS on 03-8-2019. The Seats under DDH shall also be filled up on 03-8-2019 as mentioned above.

It is further notified that :-

- (i) The candidate willing to participate in the counselling shall have to register themselves in the BOPEE Office for purposes of attendance between 8 AM to 10AM on the schedule day of counselling.
- (ii) Those who are participating for the first time in the counselling shall have to pay a counselling fee of Rs 1500/- before being allowed to participate in the counselling.
- (iii) The seats becoming available due to upgradation if any shall also be filled up during the said round of counselling as hethertofore the counselling will stop immediately when all the seats are filled up.
- (iv) The candidates should weigh their chances of allotment/upgradation before taking a decision to participate in the counselling so as to avoid un necessary rush in the Board office.

**NOTE:-** The candidates selected/upgraded shall be given limited time to join in view of the counselling schedule fixed by the MCI. Further, other terms and conditions shall remain same as notified from time to time and those contained in the Information Brochure.
