

In view of various representations received from candidates that they have not been able to join the colleges allotted to them as a consequence of allotment/upgradation in MBBS/BDS seats in pursuance of counselling held on 02-08-2019 and 03-08-2019 and notified vide Notification No. 78-BOPEE of 2019 dated 02-08-2019 and Notification No. 80-BOPEE of 2019 dated 03-08-2019 and in partial modification of said Notifications, it is hereby notified that:-

- (i) the joining time in respect of MBBS has been extended upto 13th of August, 2019 (4.00 p.m.);
- (ii) the Colleges shall accept the cheques also from the candidates in case of any difficulty being faced by the candidates due to closure of banks etc;
- (iii) the Colleges shall furnish the shortfall, if any, on 13th of August (4.30 p.m.);
- (iv) ASCOMS in the first instance shall submit the shortfall to the BOPEE, which after reviewing the position shall decide upon operation of waiting list as forwarded to the College in view of the prevailing situation; and
- (v) the date of joining of BDS candidates allotted to IDS or upgraded from IDS to Government BDS Colleges shall, however, be allowed to join upto 20th of August, 2019 (4.00 p.m.) in view of time available in accordance with the Dental Council of India admission schedule for 2019-20. The BDS Colleges shall furnish the shortfall, if any, upto 20th August, 2019 (4.30 p.m.)
