It is hereby notified for the information of the eligible and willing candidates, who have qualified NEET 2019, that:-

- 28 seats in the BDS have been reported to be unfilled by the IDS, (private) Dental (i) College Sehora, Jammu due to non-joining of the candidates selected vide Notification No. 87-EOPEE of 2019 dated 30-08-2019 and those are to be filled up.
- The eligible and willing candidates who want to compete against the said seats may (ii) report to BOPEE office Jammu / Srinagar w.e.f 07-09-2019 to 11-09-2019 (including holidays and off days) for registration and consideration for preparation of merit list for admission.
- All candidates upto qualifying score (OM= 134 and Reserved Categories =107) shall be (iii) eligible including those who were earlier selected but failed to join, and those who had not registered so far with the BOPEE, but have qualified NEET Exam 2019.
- The fresh registrants shall have to produce all documents in original alongwith with a (iv) set of documents duly attested by the candidates and shall have to deposit the counselling fee of Rs. 1500/- (Rupees one thousand and five hundred) only for which on spot institutions shall be given to the candidates on the basis of their merit.
- The Board shall notify the merit list earlier on day to day basis or on 11-09-2019 and (v) the candidates selected on basis of merit shall have to report to the College latest by 15<sup>th</sup> September, 2019 for taking admission.

- 1. Any candidate approaching the College directly for admission shall be advised by the College to report to the BOPEE Office Jammu / Srinagar for further action as above.
